

## **Puppy Purchase Agreement**

As a dedicated hobby kennel breeder of Golden Retrievers, my primary responsibility is to protect our puppies. Therefore I have developed our contract to protect the purchaser, breeder and most of all, the puppy. Under the terms of this contract, the undersigned parties agree to the following conditions with regard to the puppy described below:

## PURCHASE AGREEMENT:

- **Purchase Price:** The purchase price of the puppy is \$1,800.
- **Deposit:** Breeder hereby accepts a deposit of \$500, which shall be paid concurrently with the execution of this Purchase Agreement and shall be applied towards the purchase price of the puppy. Breeder shall not hold a puppy for a Buyer until \$500 deposit has been received. The deposit can be paid in cash, check, or credit card through PayPal on our website <a href="https://allshadesofgoldens.com/pay-here/">https://allshadesofgoldens.com/pay-here/</a>. (PayPal fees apply)
- **Puppy Picks:** The puppies will picked in the order the deposit is received. Visits will be scheduled for the Buyer to pick their puppy when they are 5-6 weeks of age. We wait until this age so that their immunity has built up and their personalities are starting to show. As the Breeder, we reserve the right for first pick of the litter.
- Balance: The balance of \$1,300 is to be paid in full at the time of pick up by either <u>cash or</u> <u>credit card</u> through PayPal on our website <u>https://allshadesofgoldens.com/pay-here/</u>. (PayPal fees apply) <u>No checks will be accepted on the day of pick up</u>. If you would like to pay by check, please send at least 5 days in advance of pick up date, so that check can clear.
- **Registration:** This puppy is eligible for limited AKC Registration as defined by the American Kennel Club and can be registered online. The registration papers will be provided on the day the puppy is picked up.

## BREEDER AGREEMENT:

- Both the Sire and Dam are purebred and AKC registered.
- The Breeder has exercised every practice known by ethical breeders at this time to produce sound, healthy Golden Retrievers.
- The puppy is in good health at the time of purchase. The puppy has been loved daily and properly cared for. The puppy has been thoroughly examined by a licensed veterinarian, received their first set of vaccinations, and been de-wormed. Vaccination records and a health certificate will be furnished when the puppy is picked up.
- As of the signature date of this contract, both Sire and Dam have NOT been affected by cancer, epilepsy or any other known illnesses.
- The Breeder does not assume any liability for any injury or veterinarian expenses to purchased puppy once picked up by the buyer.

## **BUYER AGREEMENT:**

- Buyer agrees to have the puppy examined by a licensed and reputable Veterinarian within 5 business days of taking possession of the puppy to verify the puppy is in good, sound health. If the veterinarian finds the puppy to be at risk due to congenital defect (existing at birth), owner shall notify Breeder and provide a written statement from licensed Veterinarian describing the puppy's condition and shall return, at Buyer's expense, the puppy and registration papers to the breeder within three days of the examination. If the puppy is in the same condition mentally and physically as when originally purchased, the Breeder will give a full refund. All Veterinary bills are at the buyer's expense. This return does not include worms, fleas, mites, ticks, coccidia, giardia, mange or any other parasites as they are common in dogs and puppies. It also does not include ingestion of foreign objects, ingestion of food or chemicals, or physical injury contracted or incurred following Buyer's receipt of puppy. For purposes of this agreement, a reputable veterinarian is one who is duly licensed by the state in which he practices and maintains an active, full-time private practice of which the care of dogs owned as pets is the most significant element of his practice.
- The Buyer agrees that this dog will be a household companion. Buyer agrees never to tie or chain the puppy out or allow the puppy to roam unsupervised. Shock collars are strongly discouraged for this breed as it can make them very skittish.
- In the event of the puppy's death, the Buyer must notify the Breeder within 36 hours.
- The puppy is to receive proper veterinary care and vaccinations for the duration of its life. The next series of puppy vaccines is due in 2-4 weeks after pickup. Please check with your veterinarian for their puppy vaccination schedule.
- The Buyer agrees to provide high-quality, preferably grain-free, dog food. The puppy will be fed Acana Puppy & Junior Dry Dog Food while with the Breeder.
- The Buyer agrees NEVER to sell/give/trade/transfer ownership of this puppy to any large commercial breeding establishment, any agent, any wholesaler, or any party not included in the original sales agreement.
- In the event, at any future time and for any reason, the Buyer cannot keep this puppy, the Buyer should contact the Breeder and the Breeder will make arrangements to assume ownership/care of the puppy.
- Buyer agrees to release and hold harmless the Breeder for any and all liability, damages, or injuries, caused either directly or indirectly by this dog to any person, whether actual or legal, or to any property, whether real or personal. Furthermore, Buyer assumes full liability for any damages or injuries, whether actual or legal, or to any property, whether real or personal, after receiving possession of this dog.

*Modification:* This agreement may be modified only by a written agreement signed by all parties. There shall be no oral modifications to this agreement.

I have read, understand and agree to abide by the terms of the items contained in this contract. I understand that this document contains the entire agreement of the parties and shall be binding to the parties signing, as well as their heirs, successors, and legal representatives.
